Annualized premium of new business was 109 million yen, 95% of May 2016

TOKYO, June 7, 2017 – LIFENET INSURANCE COMPANY (TSE Mothers 7157, President Daisuke Iwase, URL: http://ir.lifenet-seimei.co.jp/en/) announces the monthly business performance for May 2017.

Annualized premium^{*1} of new business in the month of May 2017 was 109 million yen (95% of May 2016). The number of applications was 3,139 (100% of May 2016), with the number of new business at 2,442 (96% of May 2016). Accordingly, annualized premium^{*1} of policies-in-force was 10,210 million yen. The number of policies-in-force as of the end of May 2017 resulted in a total of 242,379, and sum insured of policies-in-force stands at 1,976,419 million yen.

In May 2017, insurance premiums and claims and benefits recorded 839 million yen (107% of May 2016) and 126 million yen (61% of May 2016), respectively.
