Annualized premium of new business was 196 million yen, 179% of June 2017

TOKYO, July 6, 2018 – LIFENET INSURANCE COMPANY (TSE Mothers 7157, President Ryosuke Mori, URL: http://ir.lifenet-seimei.co.jp/en/) announces the monthly business performance for June 2018.

Annualized premium*1 of new business in the month of June 2018 was 196 million yen (179% of June 2017) with the number of new business at 4,573 (180% of June 2017). Accordingly, annualized premium*1 of policies-in-force was 11,529 million yen. The number of policies-in-force as of the end of June 2018 resulted in a total of 272,846, exceeding 270,000 policies-in-force, and sum insured of policies-in-force stands at 2,106,362 million yen.

In June 2018, insurance premiums and claims and benefits recorded 939 million yen (111% of June 2017) and 199 million yen (161% of June 2017), respectively.
