October 2018: MONTHLY DISCLOSURE

New business performance is a record high result

TOKYO, November 7, 2018 – LIFENET INSURANCE COMPANY (TSE Mothers 7157, President Ryosuke Mori, URL: https://ir.lifenet-seimei.co.jp/en/) announces the monthly business performance for October 2018.

New business performance in the month of October 2018 recorded the historical high for the first time in 6 years which was achieved in May 2012. Annualized premium*1 of new business was 278 million yen (178% of October 2017), and the number of new business was 6,389 (179% of October 2017).

Accordingly, annualized premium*1 of policies-in-force was 12,188 million yen. The number of policies-in-force as of the end of October 2018 resulted in a total of 287,954, and sum insured of policies-in-force stands at 2,183,345 million yen.

In October 2018, insurance premiums and claims and benefits recorded 989 million yen (114% of October 2017) and 147 million yen (97% of October 2017), respectively.
