Annualized premium of policies-in-force was 17,471 million yen, 121% of October 2019

TOKYO, November 9, 2020 – LIFENET INSURANCE COMPANY (TSE Mothers 7157, President Ryosuke Mori, URL: https://ir.lifenet-seimei.co.jp/en/) announces the monthly business performance for October 2020.

Annualized premium*1 of new business in the month of October 2020 was 314 million yen (107% of October 2019), and the number of new business was 7,342 (104% of October 2019).

Accordingly, annualized premium*1 of policies-in-force was 17,471 million yen. The number of policies-in-force as of the end of October 2020 resulted in a total of 410,662, and sum insured of policies-in-force stands at 2,828,531 million yen.

In October 2020, insurance premiums and claims and benefits recorded 1,412 million yen (120% of October 2019) and 284 million yen (117% of October 2019), respectively.
