Notice Regarding Changes in Management Structure

Strengthen the function of the Board of Directors as a Monitoring Board with a majority of Independent Outside Directors

TOKYO, May 14, 2024 – LIFENET INSURANCE COMPANY (TSE Growth 7157, President Ryosuke Mori, URL: https://ir.lifenet-seimei.co.jp/en/) announces the changes in composition of the Board of Directors, the Directors, and Executive Officer. These are subject to the approval of the proposals at the 18th Annual General Meeting of Shareholders (hereafter, the "Meeting") scheduled to be held on June 23, 2024. The background of newly elected Director is summarized in Appendix.

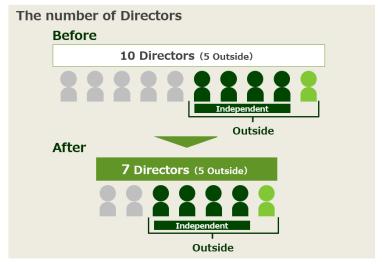
1. Change in composition of the Board of Directors

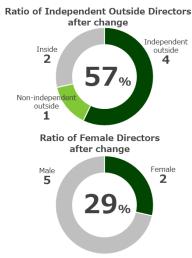
The Company has been continuously working to strengthen and enhance corporate governance since starting business in 2008 in order to achieve sustainable growth and increase corporate value over the medium-to long-term.

Recently, the Company will change the composition of the Board of Directors after the conclusion of the Meeting to have a majority of the members are Independent Outside Directors with the objective of strengthening the supervisory function of the Board of Directors and further enhancement of the separation of supervisory and executive functions. The number of Directors will be reduced from ten (10) to seven (7) to increase the efficiency and effectiveness as a Monitoring Board. The percentage of Female Directors on the Board of Directors will be 29%, thereby further promoting the Company's diversity.

In addition, the independence of the Audit and Supervisory Committee will be further reinforced as all members of the Committee will be Independent Outside Directors after the conclusion of the Meeting.

The Company aim to further strengthen and enhance corporate governance by increasing the effectiveness of the Board of Directors.
