Annualized premium of policies-in-force was 32,560 million yen, 119% of September 2023

TOKYO, October 9, 2024 - LIFENET INSURANCE COMPANY (TSE Growth 7157, President Ryosuke Mori, URL: https://ir.lifenet-seimei.co.jp/en/) announces the monthly business performance for September 2024.

Annualized premium*1 of policies-in-force for individual insurance and group credit life insurance combined was 32,560 million yen as of the end of September 2024 (119% of September 2023).

Annualized premium of policies-in-force for individual insurance was 26,105 million yen (106% of September 2023) and annualized premium of policies-in-force for group credit life insurance was 6,454 million yen (251% of September 2023) as of the end of September 2024.

Annualized premium is the amount of money equivalent to what is to be paid to have the insurance coverage for one year. All payments for Lifenet products are in monthly installments, we calculate annualized premium as multiplying the monthly premium (for GCL, expected premium income for the next month based on the in-force business) by 12 months.
