
February 2014: MONTHLY DISCLOSURE

Policies-in-force exceeded 200,000 in five years and nine months since commencing business operations

TOKYO, March 7, 2014 – LIFENET INSURANCE COMPANY (TSE Mothers 7157, President & COO Daisuke Iwase, URL: http://ir.lifenet-seimei.co.jp/en/) announces the monthly business performance for February 2014.

The number of applications in the month of February 2014 was 4,234 (58% of February 2013), with the number of new business at 3,301 (63% of February 2013). Accordingly, the number of policies-in-force as of the end of February 2014 resulted in a total of 201,295, exceeding 200,000 on February 12 in five years and nine months since commencing business operations, annualized premium^{*1} of policies-in-force was 8,010 million yen and sum insured of policies-in-force stands at 1,689,686 million yen.

In February 2014, insurance premiums and claims and benefits recorded 658 million yen (121% of February 2013) and 96 million yen (179% of February 2013), respectively.
