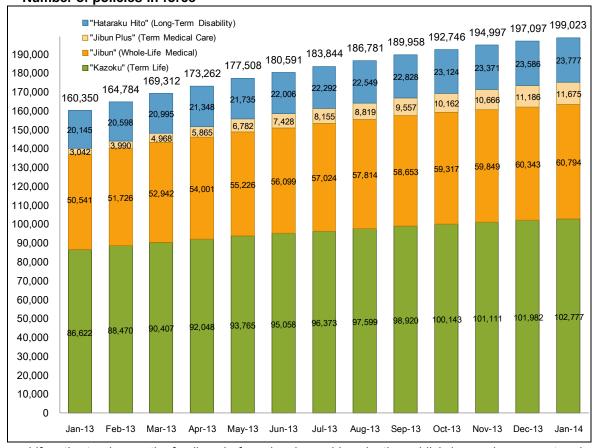

January 2014: MONTHLY DISCLOSURE Monthly Insurance Premiums Recorded 122% of January 2013

TOKYO, February 7, 2014 – LIFENET INSURANCE COMPANY (TSE Mothers 7157, President & COO Daisuke Iwase, URL: <u>http://ir.lifenet-seimei.co.jp/en/</u>) announces the monthly business performance for January 2014.

The number of applications in the month of January 2014 was 4,892 (59% of January 2013), with the number of new business at 3,010 (57% of January 2013). Accordingly, the number of policies-in-force as of the end of January 2014 resulted in a total of 199,023 and annualized premium^{*1} of policies-in-force was 7,927 million yen and sum insured of policies-in-force stands at 1,674,041 million yen.

In January 2014, insurance premiums and claims and benefits recorded 652 million yen (122% of January 2013) and 97 million yen (169% of January 2013), respectively.
