Started airing new TV commercial series with pro baseball players


TOKYO, September 6, 2013 - LIFENET INSURANCE COMPANY (TSE Mothers 7157, President & COO Daisuke Iwase, URL: http://ir.lifenet-seimei.co.jp/en/) announces the monthly business performance for August 2013.

The number of applications in the month of August was 6,247 (93% of August 2012), with the number of new business at 3,939 (82% of August 2012). Accordingly, the number of policies-in-force as of the end of August 2013 resulted in a total of 186,784; annualized premium of policies-in-force was 7,485 million yen; and sum insured of policies-in-force stands at 1,591,961 million yen.

In August 2013, insurance premiums and claims and benefits recorded 614 million yen (130% of August 2012) and 49 million yen (83% of August 2012), respectively.

Lifenet started airing new TV commercials from August 1, 2013, one of which uses famous baseball players of the Hokkaido Nippon-Ham Fighters.
