
Monthly insurance premiums recorded 132% of July 2012, exceeding 600 million yen

TOKYO, August 7, 2013 - LIFENET INSURANCE COMPANY (TSE Mothers 7157, President & COO Daisuke Iwase, URL: http://ir.lifenet-seimei.co.jp/en/) announces the monthly business performance for July 2013.

The number of applications in the month of July was 5,603 (78% of July 2012), with the number of new business at 4,330 (86% of July 2012). Accordingly, the number of policies-in-force as of the end of July 2013 resulted in a total of 183,849; annualized premium*1 of policies-in-force was 7,381 million yen; and sum insured of policies-in-force stands at 1,572,389 million yen.

In July 2013, insurance premiums and claims and benefits recorded 607 million yen (132% of July 2012) and 35 million yen (117% of July 2012), respectively.
