Annualized premium of policies-in-force was 8,996 million yen

TOKYO, September 7, 2015 – LIFENET INSURANCE COMPANY (TSE Mothers 7157, President & COO Daisuke Iwase, URL: http://ir.lifenet-seimei.co.jp/en/) announces the monthly business performance for August 2015.

Annualized premium^{*1} of new business in the month of August 2015 was 88 million yen (85% of August 2014). The number of applications was 2,547 (84% of August 2014), with the number of new business at 1,858 (86% of August 2014). Accordingly, annualized premium^{*1} of policies-in-force as of the end of August 2015 was 8,996 million yen, the number of policies-in-force resulted in a total of 218,637, and sum insured of policies-in-force stands at 1,862,470 million yen.

In August 2015, insurance premiums and claims and benefits recorded 743 million yen (108% of August 2014) and 117 million yen (137% of August 2014), respectively.
