488 payments for the 1Q of FY 2012

TOKYO, July 17, 2012 - LIFENET INSURANCE COMPANY (TSE Mothers 7157) announces the report on the number of insurance payments for the first quarter of fiscal year 2012, ending March 31, 2013.

The number of insurance payments made in the first quarter of FY2012 resulted in 488 cases, 7 of which were insurance claims and 481 benefits. There were 19 incidents which were assessed to be inapplicable during the same quarter.

Lifenet believes the most important responsibility for an insurance company is for claim payments to be made accurately and without delay, and the Company thrives to continue to accomplish this.
