FY2014 1Q: INSURANCE PAYMENTS REPORT

1,241 payments for the 1Q of FY2014

TOKYO, July 15, 2014 - LIFENET INSURANCE COMPANY (TSE Mothers 7157, President & COO Daisuke Iwase, URL: http://ir.lifenet-seimei.co.jp/en/) announces the report on the number of insurance payments for the first quarter of fiscal 2014, ending March 31, 2015.

The number of insurance payments made in the first quarter of FY2014 resulted in 1,241 cases, 19 of which were insurance claims and the remaining 1,222 benefit claims. There were 56 incidents which were assessed to be inapplicable during the same quarter.

Lifenet believes the most important responsibility for an insurance company is to make claim payments accurately and without delay, and we thrive to continue to accomplish this. Lifenet makes every effort to ensure payment of insurance claims and benefits are made to the designated account within 5 business days^{*1} of receiving all necessary documents.

Since Lifenet has made improvements to the insurance claim and benefit payment process in February 2014, it is possible for payments to be made to the designated bank account in a minimum of two days^{*1} after Lifenet receives all necessary documents. As the result of that, in the first guarter of FY2014, the average insurance payment was made in 2.84 business days.^{*1}
